

REGISTRATION AGREEMENT & LIABILITY WAIVER

STINGRAY SHUFFLE SATURDAY, MARCH 8, 2014

I have the authority to register and/or Act as Agent. I represent and warrant to Hackman Events LLC and Go Time that I have full legal authority to complete this event registration on behalf of myself and/or any party I am registering.

If registering another party, I agree that the terms of this Registration Agreement and Liability Waiver shall apply equally to all Registered Parties I register.

I understand that participation in the STINGRAY SHUFFLE on SATURDAY, MARCH 8, 2014 in HAMPSTEAD, NC, and any road race/obstacle course, is a potentially hazardous activity, and that I or any Registered Party I registered should not enter the event unless I am medically able and properly trained. I agree to abide by any decision of a race official relative to my ability to safely complete the event. I understand that the event may be held on public roads and facilities open to the public during the event and hazards may occur. I assume all risks associated with running/walking/obstacles in the STINGRAY SHUFFLE or any Go Time event by Hackman Events LLC. This includes, but not limited to, falls, contact with other participants, the effects of weather including high heat and/or humidity, low temperature, vehicle traffic, conditions of the road and course, and all risks being known and appreciated by me.

I also grant permission for the use of any photographs, motion pictures, recordings or any other record of my participation in this event for any legitimate purpose.

I understand that if the race is canceled because of circumstances beyond the control of the race committee and sponsors, including, but not limited to unsafe weather conditions or governmental ban, my entry fee will not be refunded. I understand that if I cancel my registration I will be subject to the following refund schedule: More than 60 days from event= Full Refund; Less than 60 days, but more than 30 days from event= 50% refund; Less than 30 days from event= No Refund.
